# OFFSHORE UPDATE MUAWABRANCH

#### Comrades

Thanks to those that participated in last Friday's Offshore members hookup. The report was well received by the membership, given the feedback that's come through since.

This report will cover off on some of that meeting and other matters affecting our industry.

### OFFSHORE EBA CAMPAIGN

As endorsed by the members at last Fridays meeting, the Branch is calling for the MUA delegates from each employer to formulate a log of claims committee. This meeting will be held at the WA Branch on February 10th, 2022 and is intended to be face to face.

Delegates at each of those companies will be contacted in the coming days regarding this meeting.

The aim of this meeting will be to work through the 120+ claims and identify which of the claims the membership will be seeking to pursue as key claims in this next round of bargaining. All industry matters will need to be considered, including the GO Offshore EBA, where the DOF negotiations are at, where we landed with the manning agents and the broader state of the Oil and Gas industry.

The broader membership is encouraged to speak with their delegates so that any specific claims members are seeking are discussed and debated at this meeting.

#### **UPDATE ON AGREEMENTS**

To date, we have reached agreement with AOS, OSM, Entier, Focus, OSM and are finalising an agreement with ESS and continuing to meet with Rigforce. All which expire in 2022.

MMA and DOF are currently the only 2 agreements that are out of date. Solstad, Swire and Maersk all expire between March and May next year.

### DOF PROTECTED ACTION

The DOF members have been engaged in a series of protected action in support of a new EBA. So far, these members have taken up the fight to this company on 3 separate occasions with a significant amount of action planned in the coming days.

These members are not only fighting for their rights, but they are also fighting for all future DOF employees and the broader seafaring membership.

It appears that DOF management may be seeking to take us on a legal route, as they have indicated that we are not bargaining in good faith. We disagree with that as we have genuinely been trying to land a deal with them.

The MUA will continue to bargain with DOF with a view of reaching an agreement.



## LABOUR SHORTAGE

There is a significant shortage of workers nationally and internationally in all fields of work, but specifically we are seeing a shortage of Australian seafarers nationally. Not only are we short of seafarers in the oil and gas sector, we are also short in other maritime sectors such as TT line that are in need of over 20 IRs throughout the Christmas period.

At last weeks meeting, members endorsed that no member should return or remain on board a vessel without running it past the appropriate official in the first instance. All instances need to be considered on a case by case basis.

While there is a shortage nationally, some employers have been lying to our members saying that that there isn't anyone available - so that they can remain on board and work over-cycle or are asking our members to return early. There may be some members in various states across the country that are able to go to work and they should be exhausted in the first instance.

There is a significant amount of work coming up across the next few years. Too much for the current seagoing membership. Hence, we need to deal with this issue now.

Again, at Friday's meeting, the members moved that the Union begins gathering information on seafarers that are either retired and are prepared to return to the industry to assist with the shortage or members that have left the industry because of the downturn we recently faced. Those members would need to revalidate and get a valid AMSA medical.

Jack McCabe will be collating a list of retired seafarer's or seafarers who left the industry but wish to return. If anyone knows a seafarer wishing to get back in the industry, get them in touch with Jack as soon as possible via email jack.mccabe@mua.org.au.

I would also like to commend the rank and file for their diligence in sending through the crew lists. Please keep them coming!

### WA'S HARD BORDER COMES DOWN

At long last, the WA Premier has announced that hard borders will come down on February 5th, 2022. Of course, there are strings attached...

- 1. Anyone entering from the East must be double vaccinated
- 2. Anyone entering must return a negative PCR test within 72 hours of joining. Given that most states are open for business, suspect that this may be difficult.
