A further round of meetings were held in the week commencing 17<sup>th</sup> October. The first of the new build Gas escort Tugs has arrived in Gladstone and the first L.N.G. Tanker is due to arrive in the Port on 20<sup>th</sup> December.

Negotiations are continuing with management to attempt to progress the Towage Enterprise Agreement, inclusive of the new roster to accommodate the 5 extra Tugs that will be required for the expanded Port operations.
