# Proposed MUA / CFMEU merger - Brisbane Ferries - ETU Conference

### **Proposed merger of MUA and CFMEU** discussed at National Council

MUA QLD officials Bob Carnegie and Jason Miners took part in a week of robust discussions at last week's MUA National Council meeting.

One major issue discussed in Sydney was the

proposed merger of the MUA with the Construction, Forestry, Mining and Energy Union (CFMEU).

There are three points that all members need to be aware of. First, the union has told the CFMEU that the MUA wants to preserve our name, our rules and our democratic structures as a division within any merged union. Second, the proposed merger is to be voted on at the MUA Ouadrennial Conference in February 2016. Third, that a process of finalising the rules, structure and identity of the merged union are to be clearly defined and voted on by every MUA member in a plebiscite.

The Branch believes that the proposed merger is, in

general, a positive move for the left of the union movement and for the Australian working class. While the divisions of the new union would keep their autonomy, there would be a merging of the strength and solidarity that both unions need in order to forge ahead in the huge industrial, political and

legal challenges that we face every day. Handled properly, this merger does not mean a loss of identity but a strengthening of the great ideals that the CFMEU and the MUA have always stood for.

Nevertheless, the decision to merge our unions ultimately rests in the hands of the MUA

> membership. This will be determined by the votes of all members in a future membership plebiscite.

## **Campaign at Brisbane** Ferries steams ahead

WORKERS at Transdev Brisbane Ferries are responding marvellously to the MUA's continued campaign for a fair go for Ferry workers. Central QLD Organiser Paul Petersen has been leading the charge on the Brisbane River.

Over the past few weeks, Paul has been regularly visiting the terminals and smoko rooms and has signed up dozens of new members to the MUA. New "A Fair EBA for Ferry Workers" T-shirts have been dished out and stickers with the same slogan are plastered up at work sites.

From all reports, MUA

members are clearly angry at their treatment at the hands of Transdev and are united in their determination to fight for a fair go.

In an attempt to turn the tide, Transdev management have inundated the workforce with company memorandums. They are trying to tell us that everything is fine and that the EBA is almost finalised. But we are not buying their propaganda.

More ominously, the MUA QLD Branch has heard that Transdev is considering moves to have Paul Petersen's Right of Entry provisions removed from him. But we have a message for Transdev. We will not stand idly by while our right to organise is undermined. Every action that Paul has undertaken is in line with all relevant provisions of the Fair Work Act and has the full and unqualified backing of the MUA QLD Branch. The Branch will, without hesitation, defend any attack on Paul's right to organise and fight any attempt to have his – or anyone else's - Right of Entry provisions removed.

The campaign for a fair go for Ferry workers continues. A protest targeting the Brisbane City Council is planned for next week [day and venue to be announced – contact the Branch on 3395 7215]. MUA members at Brisbane Ferries should also receive their Protected Action Ballots in the mail very soon. We urge all MUA members at Brisbane Ferries to vote YES for legal, protected industrial action. All we want is a fair go for Ferry workers.

#### **ETU QLD / NT Major Projects Conference**

THE QLD / NT Branch of the Electrical Trades Union (ETU) held its Major Projects Delegates Conference today (October 22). MUA QLD Branch Secretary Bob Carnegie addressed the ETU Conference on behalf of the MUA.

Bob spoke passionately about the continued and ongoing solidarity and unity between the two QLD unions, and referred to the fact that the ETU was the first union to offer its solidarity and assistance at the start of the Hutchison dispute (a fully-equipped ETU van has been a regular fixture outside the terminal).

Bob also congratulated the ETU for its role in the dispute that took place during the construction of the INPEX liquefied natural gas (LNG) facility off the coast of Darwin. If not for the work of the ETU, a major contractor would have succeeded in its attempt to use foreign labour and pay them around one-quarter of the current local rates of pay.

Bob also conveyed to the Conference his hope and believe that the fight for justice for maritime and construction workers will see the MUA and ETU coming even closer together in the years ahead.
