## **Hay Point Tugs in Battle for Union Existence**

A MEETING OF all Hay Point MUA members was held on Wednesday 18/5/16 whereby discussion took place on their fight for survival.

These members do the Towage work at the world's largest coking coal terminal owned by BMA.

For 45 years our tug men and women have worked in all sorts of weather, in a dangerous and difficult job, 24/7, 365 days per year.

BMA a conglomerate of BHP and Mitsubishi are launching a sophisticated de unionisation drive to deny our members the right to work.

BMA are engaging Riv Tow, a savagely anti-union company to set up 'Partnership' arrangements to do the towage work for the terminal. These 'Partnership' agreements are all about destroying any responsibility an employer has in relation to an employee.

Under these 'Partnership' arrangements, an employee becomes part of a trust and has ABSOLUTELY NO RIGHTS whatsoever under the Fair Work Act as you are trustee not an employee, so you are not entitled to holidays, long service leave, sick days, workers compensation etc.

It is an absolute and total attack on the very essence of what unions have fought for in this country and around the world.

After yesterday's meeting members resolved to fight this industrially, socially, legally and politically.

The MUA Queensland Branch will leave no stone unturned in this fight. Our National Office will also be heavily involved.

At yesterday's meeting the State President of the CFMEU mining division, Stephen Smyth spoke passionately in support of our struggle.

Jason Lund, president of the QCU spoke eloquently on the importance of maintaining the struggle. Jason comes from great stock, I would die beside his Dad John, one of the most genuine and fearsome trade union Organiser's I have ever worked with. John and I worked together in my BLF days.

Jim Pearce the State member encompassing part of the coal fields has offered his unqualified support.

This is a fight we must all get behind and support. The Branch will keep members informed on a regular basis.

## **Report from Bob Carnegie**

RECENTLY I TOOK annual leave of which a major part was my wife and I walking from Porto in Lisbon to Santiago De Compestella in Spain. We finished off the last 5 days by visiting Paris.

When some terrific rank and file Dockers from Transcm CSV union wanted to meet of course I said yes. These two terrific militants Marc Storm and Bart travelled from Antwerp and Zebrugge to meet with me. We had a few beers and a small meal and shared experiences of being militants on the waterfront and the huge importance of international solidarity in defending the rights of Dockworkers everywhere. These two men succinctly and powerfully put forward the huge importance the future the IDC will play in fighting for the rights of workers everywhere but particularly focused on Dockworkers.

The next Monday May 9 was taken up with a meeting with Tony Haubois the General Secretary of the French Dockers Union. We discussed many issues, including the effects of automation on Dockworkers lives and how fundamentally it is being

used by Terminal Operators as a means of controlling the

workforce and in many respects was less productive than a non-automated Terminal. The French Dockers have decided that they will oppose automation based on some of these grounds.

Tony also explained that in November 2015 legislation was passed in France that it was now LAW that all work done in discharging and loading of ships was the work of the French Dockers. This has further cemented the strength of the French Dockers Union in their battles.

Tony also mentioned the growing importance of the IDC and the importance of the Conference in Miami in September this year and the big questions of growth and battles we will face.

I thanked Tony and the Union that he leads for the support they gave us during the Hutchison dispute and he simply replied that "it was their duty to support workers in struggle."

# **MUA Gets a Win for Sacked QN Members**

IN WHAT HAS been a long battle for Queensland Nickel members who were sacked during the first days of the QNI collapse, the MUA has had a win on behalf of our members.


The MUA was the only union on site that made a claim for unfair dismissal when its members were dismissed on the 15<sup>th</sup> of January, 2016. Our Union cited lack of consultation on the matter of the so-called 'redundancies' and questioned the process used to select who would be made redundant.

The affected members have agreed to FTI Consulting's offer to settle the claim by paying those members' wages and accrued leave up to March 11, which was when the operation closed down and the remainder of the workforce was made redundant.

While this does not make up for the hurt that has been felt by members who lost their jobs and the wider community, it does compensate those members affected on the issue of unfair and underhanded treatment early on in the process by the Clive Palmer-owned company.

The affected members wish to pass on their thanks to the Queensland Branch and Adam Jacka at National Office for their work and assistance on the claim.

#### REPORTS FROM THE IDC...

# International Dockworkers Council Exceeds 85,000 Affiliates and Puts the Focus on Health, Safety and Training

APRIL 11 2016 NEW JERSEY - The General Coordinator of the International Dockworkers Council (IDC), Jordi Aragunde, met with IDC Zone Coordinators this week at the International Longshoremen's Association (ILA) headquarters in New Jersey (US). The meeting involved a discussion of important topics to be held in the coming months.

Dockworkers at the Ports of Brisbane and Sydney (Australia) and the Port of Koper (Slovenia) make up some of the new organisations to affiliate to IDC from around the globe. These new affiliates contribute to IDC's record growth, which now exceeds 85 000 members. The IDC General Coordinator accompanied by several Council Members will soon hold meetings to honour these new affiliates. Since September 2015, 8085 workers have joined the IDC.

The New Jersey meeting included a discussion on joint actions and common problems faced by dockworkers

together with new training, safety and prevention projects launched in the African and South American Zones.



The meeting also served as an initial planning session for the IDC General Assembly to take place from September 27 - 29 in Miami (USA). The assembly will include a Conference on port automation to explore the impact of port automation on dockworkers.

IDC Zone Coordinators debated the strength of evidence associated with public-private mismanagement, in regard to the privatisation of ports in Greece and Slovenia. The European Courts recently ruled against

dockworkers over operational systems in Norway, Belgium and Spain. This conflict centres on the variation of authorities in African, European or Latin American ports, which include both public administrations and private companies.

Finally, at the New Jersey meeting it was decided to make public all formal accords and meeting records that have been maintained during the last months with state entities and international institutions, such as the International Labour Organization (ILO).

CGT, France); Manuel Lanon, IDC H&S Coordinator (FNPD-CGT, France); Paul Petersen, Coordinator of the Oceania Zone (MUA-QLD, Australia); Wesley Furtado (ILWU, United States); Dennis Daggett (ILA, United States); and Susana Busquets (IDC).
