BMA Dispute

LABOR SHADOW MINISTER for Employment and Workplace Relations, Brendan O'Connor attended a meeting with Hay Point Tug workers following a recent decision by BMA to award Rivtow Marine the contract to operate its tugboat fleet from July 1 2016. The move will see the loss of 22 jobs from current operator Teekay as BMA are entering into partnership arrangements which historically was set up for legal firms, medical and financial industries.

Partnership agreements will abolish the employer/employee relationship and all provisions of the Fair Work Act and will be used as an avenue to mitigate risk away from the employers and leaving all responsibilities of paying their own tax, superannuation, workers compensation and public indemnity or damage insurance falling on the individual.

Brendan O'Connor condemned the coalition government's record on workplace relations and said the member for Dawson, George Christensen is a liar. "Christensen has lied saying he will support local workers when yet he voted to oppose Labor's restrictions to 457 visa workers. So what he says and actually does are two different things and what is happening is an absolute disgrace where workers have no security."

This decision by BMA to engage in partnership arrangements has the potential to leak into other parts of our industry and is an attack based on pure ideology. We will seek an amendment to current legislation to the Partnership Act 1892 to outlaw partnerships from being

established in industries where an award or collective agreement can be demonstrated has existed.

Will Tracy spoke with confidence and driven determination about stopping this government from removing Australian maritime workers from our rightful place of work. In the offshore oil and gas industry the LNP government are trying to remove Australian workers by changing visa requirements which would allow foreign workers to take those jobs at third world conditions. In the blue water shipping industry the LNP have been colluding with shipping companies to have State police and security guards physically drag MUA members down the gangway and escort \$2 an hour foreign labour up the gangway.

Micheal O'Connor was angry and is ready to fight. The LNP are hell bent on reintroducing the ABCC. This would mean the removal of all workers' rights to silence or your right to legal advice.

As an example, if you were asked what was said in a workplace meeting and chose to excercise your right to silence, the ABCC would charge you with contempt and it would mean a mandatory six months imprisonment.

Even the lowest criminal within our society have the right to silence but the LNP will remove it from all workers under the ABCC.

It's time to get involved and get angry. The LNP are about removing YOUR RIGHTS AT WORK and where possible removing you completely and replace you with foreign slave workers.

Bowen Update

WEDNESDAY JUNE 8 we held a meeting at the Bowen Grand View Hotel. Guest speakers included Queensland Branch Secretary - Bob Carnegie, MUA Member - Dale off the MV Portland, ETU Far North Queensland Organsier – Michael "Rabbit" Haire, ALP Candidate - Frank Gilbert, ALP Senator Candidate - Jane Casey, ALP Candidate - Bronwyn Taha and RTBU/QCU - Les Moffitt.

Dale opened up the meeting, telling his story of the experiences and hardship encountered by him and his comrades onboard the MV Portland for 70 days. A very sad day that will go down in history telling of the abuse of the power and policies of the LNP and Multi-National Companies towards Australian workers.

Bob followed up telling all about the attacks upon our waterfront and Trade Unions in Australia. BMA have an agenda of destroying the MUA by implementing Partnership Agreements that take away employee rights and conditions as well as employing non-union operator "Rivtow." These Agreements are a "cancer" to worker's rights and conditions and have the potential of entering other industries after they dismantle the ports in Australia of union workers.

Labour Hire is another attack on wages for workers and it has shown workers are doing the same jobs for half the pay. The Labour Movement around the world is gaining strength and as unionists must unite to fight the ongoing attacks on organised labour around the world. If we do not fight we will become non-existent as a union losing all that has been won in the last 100 years of struggle to win the conditions and rates of pay we all enjoy today.

Rabbit explained the "Not for Sale" campaign the ETU organised and how it helped get rid of the Newman Government after one term. It shows the strength we have as a collective when we are united in struggle. He asked for everyone to volunteer to help the election campaign and get rid of the LNP.

Frank Gilbert spoke about the Toxic Casualisation of the work force and the need to fight politically and industrially to rid these attacks on workers and their conditions. 
Veteran's Mid-Year Luncheon
